It was decided that Vice-Chancellor, Delhi University will be requested to order an Expert Committee investigation into mismanagement of Provident Fund Accounts of Shivaji College. This investigation will take into account the background of mismanagement and special audit of Provident Fund accounts that has already taken place. The special audit covers the period 1990-1991 to 2008-2009.

2. The committee decided that Dr. G.P. Mishra be retained as a special invitee in all future meetings of PF committee.
3. The Committee approved that year wise rectification of provident fund accounts with interest be made in all relevant documents under the period of special audit. This work will be attended to with great care in accordance with standard accounting rules and practices.
4. The Principal informed the PF Committee that NPS accounts of all the subscribers have been updated till 31st march 2013 and all the funds have been transferred to CRA, Bombay. All subscribers of NPS have also been provided updated annual statements. The Chairman appreciated this development.
